Macroeconomic Overview

The S&P 500®'s 4.5% third-quarter return marked its eighth consecutive quarterly gain. Earnings growth has been fueling the U.S. stock rally, with earnings for S&P 500® companies outpacing year-ago levels by more than 10%. The macroeconomic landscape has been strong too: Manufacturing activity grew in September at the fastest rate since May 2004. These factors have helped push the S&P 500® up 14.2% so far this year. International stocks continued to outperform in the third quarter, with the MSCI EAFE Index gaining 5.4% and the MSCI Emerging Market rising 7.9%. The MSCI EAFE Index is up 20% year to date and the MSCI Emerging Markets Index 27.8%. Bonds have withstood two Federal Reserve rate hikes so far this year. The Bloomberg Barclays US Aggregate Bond Index returned 0.8% in the quarter and is up 3.1% year to date. High-yield bonds and emerging-markets debt have topped those returns.

Fund Overview

In 2017's third quarter, Transamerica Asset Allocation—Moderate Growth Portfolio's 3.49% return was near the 3.59% return of the blended benchmark. An overweight to foreign stocks was positive, as international stocks outpaced U.S. stocks. Overweighting emerging-markets equity was especially helpful, and built-in exposure to international small caps provided a nice boost. Overweighting emerging-markets debt also lifted returns. These positives were partly offset by a modest underweight in equity (68.1% as of 9/30/17), which comes entirely from the U.S. side, where management believes valuations are stretched. Meanwhile, the portfolio's absolute-return strategy sleeve lagged stocks in the quarter, but outpaced bonds. The absolute-return allocation is a substitute for a portion of the bond portfolio to help guard against rising interest rates.

Outlook

Morningstar considers U.S. stocks to be trading expensively following eight consecutive quarterly gains in the S&P 500® and a 37% rise since September 2015. Morningstar is therefore modestly underweighting overall equity in the portfolio while favoring foreign equities more than usual. While the portfolio is underweight equity on the whole (68.1% of assets versus the blended benchmark's 70% target), the underweight comes from the U.S. side, as foreign equity is actually overweight the benchmark. Most bonds also trade expensively amid the low-rate environment. To guard against rising interest rates, Morningstar is maintaining a below-benchmark bond portfolio duration, favoring floating-rate bank loans in the credit-sensitive sleeve, and substituting absolute-return funds for a portion of the bond exposure.
