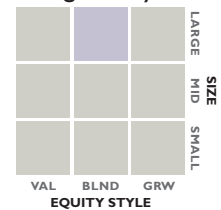

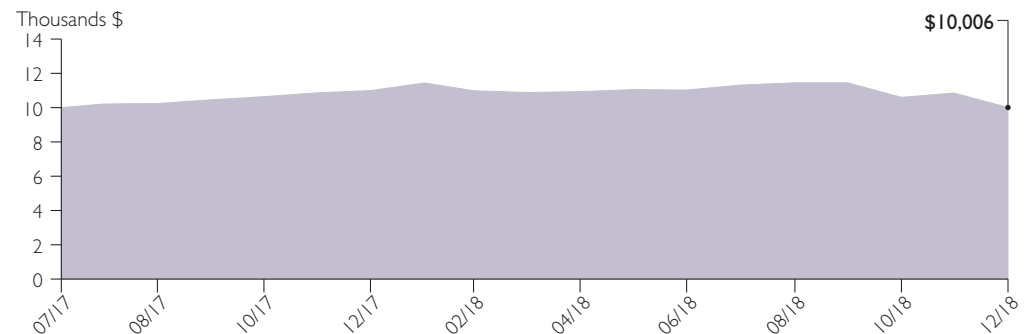
Morningstar Style Box™
