# Transamerica Recognized for Best Practices in Diversity and Inclusion

Today, Transamerica was named to the Diversity Best Practices Inclusion Index by Diversity Best Practices. Transamerica was among the 73 organizations that earned a score of at least 65% and a place on this year's index.

Diversity Best Practices (DBP), a division of Working Mother Media, unveiled its second annual Inclusion Index, providing data and insight into how participating organizations fared in three areas: diversity and inclusion practices in recruitment, retention, and advancement; organizational culture; and demographic transparency.

Transamerica fosters an inclusive culture in a variety of ways, including <a href="Employee Resource Groups">Employee Resource Groups</a> where coworkers with similar interests come together to share experiences and insight. There are 14 Employee Resource Groups across the company providing a supportive environment for raising diversity awareness, promoting inclusive behavior and many are engaged in community events related to their missions.

The Inclusion Index asked organizations to provide data in three areas:

- Adherence to best practices for fostering diversity and inclusion in recruitment, retention and advancement of people from under-represented groups—women, racial/ethnic minorities, those with disabilities, and the LGBTQ community.
- Best practices in creating an inclusive culture through leadership, accountability, communications, and employee engagement.
- Transparency in willingness to share workforce demographic data.

One hundred twenty four organizations applied and seventy three of those listed as members of the 2018 DBP "Inclusion Index" achieved at least 65% of the available points. Completed applications were collected online from December 2017 to March 2018.

"We commend their transparency as they continue to strive for excellence in creating an inclusive environment for all employees."
