

Important Information Regarding Your Fund's Distribution

This notice provides our customers with information concerning a recent distribution declared for the fund below. You are receiving this notice as a requirement to provide you with additional information regarding the distribution. It is informational only and no action is required on your part.

The amounts and sources of the distribution reported in this notice are estimates and are not being provided for tax reporting purposes. The distribution may later be determined to be from other sources including realized short-term gains, long-term gains and return of capital. During the course of the year, there may be times that the fund's estimated income and net realized capital gains may be less than the actual monthly distribution. In these cases, a portion of your distribution may be estimated to be a return of capital as indicated by the chart below. A return of capital may occur, for example, when some or all of the money that you invested in the fund is paid back to you but does not necessarily reflect the fund's investment performance.

The actual amounts and sources of the amounts for tax reporting purposes will depend upon the Fund's investment experience during the remainder of its fiscal year and may be subject to changes based on tax regulations. The final determination of the source and tax characteristics of all distributions will be made early in the following calendar year and reported to you on Form 1099-DIV. You should refer to Form 1099-DIV to determine how to report these distributions for federal income tax purposes.

During the month of March 2018, the fund declared a quarterly distribution. The distribution is estimated to be from the following sources:
